SUMMARY

Oil & Gas in Hong Kong industry profile provides top-line qualitative and quantitative summary information including: market size (value and volume 2014-18, and forecast to 2023). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The oil and gas market volume is defined as the total consumption (barrels of oil equivalent) of refined petroleum products and natural gas by end-users in each country.

The Hong Kong oil & gas market had total revenues of \$8.2bn in 2018, representing a compound annual rate of change (CARC) of -6.1% between 2014 and 2018.

Market consumption volume increased with a compound annual growth rate (CAGR) of 5.9% between 2014 and 2018, to reach a total of 173 million Barrel of oil equivalent in 2018.

The Hong Kong oil and gas market like most other markets across the globe has witnessed a strong decline in its value in the historic period thanks largely due to a steep decline in the price of crude oil.
