Oil and Gas in Kazakhstan

SUMMARY

Oil & Gas in Kazakhstan industry profile provides top-line qualitative and quantitative summary information including: market size (value 2015-19, and forecast to 2024). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The oil and gas market volume is defined as the total consumption (barrels of oil equivalent) of refined petroleum products and natural gas by end-users in each country.

The Kazakhstani oil and gas market had total revenues of \$7.9bn in 2019, representing a compound annual growth rate (CAGR) of 11.4% between 2015 and 2019.

Market consumption volume increased with a CAGR of 3.3% between 2015 and 2019, to reach a total of 233.1 million BoE in 2019.

Refined petroleum products account for the largest share of consumption as refined oil products are widely used as vehicle fuels, unlike natural gas which is mainly used in electricity generation and heating.
