SUMMARY

KEY HIGHLIGHTS

The oil and gas market volume is defined as the total consumption (barrels of oil equivalent) of refined petroleum products and natural gas by end-users in each country.

The Libyan oil & gas market had total revenues of \$5.2bn in 2018, representing a compound annual rate of change (CARC) of -13.2% between 2014 and 2018.

Market consumption volumes declined with a CARC of -2.6% between 2014 and 2018, to reach a total of 121.2 million Barrel of oil equivalent in 2018.

Libya is the holder of Africa's largest proved crude oil reserves, and the fifthlargest holder of Africa's proved natural gas reserves.
