Oil and Gas in Malaysia

SUMMARY

Oil & Gas in Malaysia industry profile provides top-line qualitative and quantitative summary information including: market size (value 2015-19, and forecast to 2024). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The oil and gas market volume is defined as the total consumption (barrels of oil equivalent) of refined petroleum products and natural gas by end-users in each country.

The Malaysian oil and gas market had total revenues of \$16.6bn in 2019, representing a compound annual growth rate (CAGR) of 1.6% between 2015 and 2019.

Market consumption volumes declined with a compound annual rate of change (CARC) of -0.6% between 2015 and 2019, to reach a total of 506.5 million BoE in 2019.

Consumption in the Malaysian market declined by 0.9% in 2019, driven down by a drop in demand for refined petroleum products.
