Oil and Gas in Portugal

SUMMARY

Oil & Gas in Portugal industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2015-19, and forecast to 2024). KEY HIGHLIGHTS

The oil and gas market volume is defined as the total consumption (barrels of oil equivalent) of refined petroleum products and natural gas by end-users in each country.

The Portuguese oil and gas market had total revenues of \$5.5bn in 2019, representing a compound annual growth rate (CAGR) of 3.3% between 2015 and 2019.

Market consumption volume increased with a CAGR of 1.3% between 2015 and 2019, to reach a total of 122.2 million BoE in 2019.

Consumption in the Portuguese market increased by 3.2% in 2019, recovering from a decline in 2018, as demand was stimulated by lower oil prices that year.
