SUMMARY

Oil & Gas in Saudi Arabia industry profile provides top-line qualitative and quantitative summary information including: market size (value 2015-19, and forecast to 2024). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The oil and gas market volume is defined as the total consumption (barrels of oil equivalent) of refined petroleum products and natural gas by end-users in each country.

The Saudi Arabian oil and gas market had total revenues of \$76.2bn in 2019, representing a compound annual rate of change (CARC) of -0.2% between 2015 and 2019.

Market consumption volumes declined with a CARC of -0.5% between 2015 and 2019, to reach a total of 1,758 million BoE in 2019.

Consumption in Saudi Arabia dropped by 2.6% in 2019, as a result of a 4.9% cut in oil production that year.
