## Abstracts

Oil and Gas in Vietnam

### SUMMARY

Oil & Gas in Vietnam industry profile provides top-line qualitative and quantitative summary information including: market size (value and volume 2015-19, and forecast to 2024). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

### KEY HIGHLIGHTS

The oil and gas market volume is defined as the total consumption (barrels of oil equivalent) of refined petroleum products and natural gas by end-users in each country.

The Vietnamese oil and gas market had total revenues of \$8.3bn in 2019, representing a compound annual growth rate (CAGR) of 2.6% between 2015 and 2019.

Market consumption volumes declined with a compound annual rate of change (CARC) of -1.4% between 2015 and 2019, to reach a total of 202.5 million BoE in 2019.

Strong growth in natural gas production, linked to the growth of oil production, suppressed prices in 2019 as supply exceeded demand.
