SUMMARY

Oil & Gas in Brazil industry profile provides top-line qualitative and quantitative summary information including: market size (value and volume 2014-18, and forecast to 2023). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The oil and gas market volume is defined as the total consumption (barrels of oil equivalent) of refined petroleum products and natural gas by end-users in each country.

The Brazilian oil & gas market had total revenues of \$61.2bn in 2018, representing a compound annual rate of change (CARC) of -12.6% between 2014 and 2018.

Market consumption volumes declined with a CARC of -1.6% between 2014 and 2018, to reach a total of 1,344.7 million Barrel of oil equivalent in 2018.

The performance of the market is forecast to accelerate, with an anticipated CAGR of 2.6% for the five-year period 2018 - 2023, which is expected to drive the market to a value of \$69.8bn by the end of 2023.
