Oil and Gas in Germany

SUMMARY

Oil & Gas in Germany industry profile provides top-line qualitative and quantitative summary information including: market size (value 2015-19, and forecast to 2024). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The oil and gas market volume is defined as the total consumption (barrels of oil equivalent) of refined petroleum products and natural gas by end-users in each country.

The German oil and gas market had total revenues of \$56.6bn in 2019, representing a compound annual growth rate (CAGR) of 3.5% between 2015 and 2019.

Market consumption volume increased with a CAGR of 0.7% between 2015 and 2019, to reach a total of 1,370.5 million BoE in 2019.

Consumption in the German market declined for a second consecutive year, although at slower pace than in 2018, when demand declined sharply as a result of a spike in oil and gas prices. Consumption was down by 0.6% in 2019, amid a decline in demand for natural gas and refined petroleum products for commercial use.
