SUMMARY

Oil & Gas in Singapore industry profile provides top-line qualitative and quantitative summary information including: market size (value 2015-19, and forecast to 2024). KEY HIGHLIGHTS

The oil and gas market volume is defined as the total consumption (barrels of oil equivalent) of refined petroleum products and natural gas by end-users in each country.

The Singaporean oil and gas market had total revenues of \$29.6bn in 2019, representing a compound annual growth rate (CAGR) of 9% between 2015 and 2019.

Market consumption volume increased with a CAGR of 4.1% between 2015 and 2019, to reach a total of 624.8 million BoE in 2019.

Consumption in the Singaporean market increased by 5% in 2019, with demand stimulated by lower oil and gas prices.
