OneBeacon, incorporated in Bermuda, is headquartered in Minnetonka, Minnesota, the US.

The company reported earned premiums of US\$1,175.6 million for the fiscal year 2015 (FY2015), representing a decline of 0.6% over FY2014. Its net written premium was US\$1,136.6 million in FY2015, representing a decline of 6.6% over FY2014.
