SUMMARY

The subscription services segment was the market's most lucrative in 2019, with total revenues of \$994.1m, equivalent to 85.3% of the market's overall value.

In 2019, Music streaming accounted for three quarters (74.4%) of Album Equivalent Sales (AES) in the UK.
