SUMMARY

The Asia-Pacific online retail sector generated total revenues of \$469.7bn in 2018, representing a compound annual growth rate (CAGR) of 23.8% between 2014 and 2018.

The electrical & electronics retail segment was the sector's most lucrative in 2018, with total revenues of \$151.7bn, equivalent to 32.3% of the sector's overall value.

A large, young, internet-savvy consumer base and rising disposable incomes are the key growth engines of the region's online retail sector, particularly in China, which dominates the region.
