The packaged water market consists of retail sale packaged water. The market is valued according to the retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2017 exchange rates.

The German packaged water market had total revenues of \$10,653.1m in 2017, representing a compound annual growth rate (CAGR) of 3.9% between 2013 and 2017.

Market consumption volume increased with a CAGR of 1.3% between 2013 and 2017, to reach a total of 14,347.0 million liters in 2017.



The German packaged water market is well developed and accounted for 31.5% of the total European packaged water market value in 2017.
