The packaged water market consists of retail sale packaged water. The market is valued according to the retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2017 exchange rates.

The Scandinavian packaged water market had total revenues of \$612.2m in 2017, representing a compound annual rate of change (CARC) of -0.1% between 2013 and 2017.

Market consumption volume increased with a CAGR of 0.5% between 2013 and 2017, to reach a total of 339.8 million liters in 2017.

Denmark remains Scandinavian's largest packaged water market with 32.4% of the overall market value in 2017.
