SUMMARY

The inpatient care segment was the sector's most lucrative in 2021, with total revenues of \$1.7 billion, equivalent to 32.2% of the sector's overall value.

The value of the Pakistani healthcare providers sector declined by 2.2% in 2021, a weaker rate compared to 2020, as a result of the health expenditure in response to the COVID-19 pandemic.
