## Key Highlights

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The paper & paperboard industry within the NAFTA countries had a total market value of \$98,973.2 million in 2023. The Mexico was the fastest growing country, with a CAGR of 9.7% over the 2019-23 period.

Within the paper & paperboard industry, the US is the leading country among the NAFTA bloc, with market revenues of \$83,924.6 million in 2023. This was followed by Mexico and Canada, with a value of \$9,117.9 and \$5,930.8 million, respectively.

The US is expected to lead the paper & paperboard industry in the NAFTA bloc, with a value of \$106,100.0 million in 2028, followed by Mexico and Canada with expected values of \$11,565.0 and \$7,830.6 million, respectively.
