The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The paper & paperboard industry within the NAFTA countries had a total market value of \$81,444.3 million in 2016. The Mexico was the fastest growing country, with a CAGR of -1.2% over the 2012-16 period.

Within the paper & paperboard industry, the US is the leading country among the NAFTA bloc, with market revenues of \$67,974.2 million in 2016. This was followed by Mexico and Canada, with a value of \$8,612.3 and \$4,857.8 million,

respectively.

The US is expected to lead the paper & paperboard industry in the NAFTA bloc, with a value of \$68,064.6 million in 2021, followed by Mexico and Canada with expected values of \$9,362.3 and \$4,994.1 million, respectively.
