Key Highlights

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The pet healthcare industry within the NAFTA countries had a total market value of \$12,018.9 million in 2023. The Mexico was the fastest growing country, with a CAGR of 7% over the 2019-23 period.

Within the pet healthcare industry, the US is the leading country among the NAFTA bloc, with market revenues of \$10,513.4 million in 2023. This was followed by Mexico and Canada, with a value of \$881.7 and \$623.8 million, respectively.

The US is expected to lead the pet healthcare industry in the NAFTA bloc, with a value of \$11,886.2 million in 2028, followed by Mexico and Canada with expected values of \$1,252.3 and \$729.9 million, respectively.
