Countries such as China, India and Indonesia are experiencing strong growth due to a bourgeoning middle-class which spends more on health and has a greater awareness of chronic diseases.

China is the largest market in the region, accounting for 46.6% of its total value in 2019, therefore its performance heavily influences the regions as a whole. The healthcare sector, particularly biopharmaceuticals, has been identified as an area of priority for the Chinese government.
