The Indonesian pharmaceuticals market had total revenues of \$5.0bn in 2020, representing a compound annual rate of change (CARC) of -0.1% between 2016 and 2020.

High levels of public debt and a contracting economy in Indonesia in 2020 is likely to put significant pressure on government spending, meaning that there is limited space for crucial infrastructure spending to support the pharmaceutical market.

The increasing threat of competition from India and China, as manufacturing and



export capacity is increased in these countries, could act as a barrier to growth in the Indonesian market.
