The G8 countries contributed \$882.6 billion in 2023 to the global pharmaceuticals industry, with a compound annual growth rate (CAGR) of 2.8% between 2019 and 2023. The G8 countries are expected to reach a value of \$1,038.8 billion in 2028, with a CAGR of 3.3% over the 2023-28 period.

Among the G8 nations, the US is the leading country in the pharmaceuticals industry, with market revenues of \$496.7 billion in 2023. This was followed by Japan and Germany, with a value of \$94.3 and \$87.2 billion, respectively.

The US is expected to lead the pharmaceuticals industry in the G8 nations with a value of \$579.7 billion in 2016, followed by Germany and Japan with expected values of \$113.9 and \$104.5 billion, respectively.
