The bank credit segment accounted for the industry group's largest proportion in 2022, with total assets of \$273.7 billion, equivalent to 57.8% of the industry group's overall value.

According to the OECD, the long-term interest rates of Portuguese banks had increased significantly during the historic period, from 1.8% per annum in December 2017 to 3.1% per annum in December 2022.
