Summary

The metals & mining market includes aluminum, steel, iron ore, coal, base metals, and precious metals. Market volume includes production volume and market value is calculated by multiplying market volume with production price.

The Portuguese metals & mining industry had total revenues of \$3.1 billion in 2022, representing a compound annual growth rate (CAGR) of 9.9% between 2017 and 2022.

The production volumes declined with a negative CAGR of 0.8% between 2017 and 2022, reaching a total of 2,131.1 thousand tonnes in 2022.

Portugal has a large mineral potential, which has resulted in the presence of sizable ore, industrial stone, and ornamental stone deposits. Currently, Portugal is a significant global producer of ornamental stones as well as one of the EU's top manufacturers of copper, tin, and tungsten concentrates.
