The growth in the Portuguese transportation services industry group is influenced by several macroeconomic factors, such as rising GDP and growing business confidence. For instance, according to the Organisation for Economic Co-operation and Development (OECD), the business confidence index in Portugal reached 101.40 in January 2022, up from 97.32 in January 2021.
