Power Generation in Germany

SUMMARY

Power Generation in Germany industry profile provides top-line qualitative and quantitative summary information including: market size (value and volume 2014-18, and forecast to 2023). KEY HIGHLIGHTS

The power generation industry volume is defined as the total electrical energy (TWh) generated within a country over the course of each calendar year.

The German power generation industry had total revenues of \$182.4bn in 2018, representing a compound annual rate of change (CARC) of -0.8% between 2014 and 2018.

Industry production volumes declined with a CARC of 0% between 2014 and 2018, to reach a total of 615.2 TWh in 2018.

The performance of the German industry is approximately in line with other European nations. High energy costs are driving efficiency measures, both in ordinary homes and in industry, to reduce consumption.
