The Scandinavian publishing market had total revenues of \$7.4bn in 2020, representing a compound annual growth rate of (CAGR) of -3.5% between 2016 and 2020.

The newspapers segment was the market's most lucrative in 2020, with total revenues of \$4.2bn, equivalent to 56.3% of the market's overall value.

Further decline in this market will be seen as social media and the prevalence of mobile devices continue to act as a disruptive force in the newspapers segment of the market. What's more, magazines will continue to struggle as the availability of substitutes, particularly online content, continues to grow.
