SUMMARY

Real Estate in South Africa industry profile provides top-line qualitative and quantitative summary information including: market size (value and volume 2015-19, and forecast to 2024). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The real estate industry looks at renting and leasing residential properties. The industry is valued using the total revenues generated by landlords via the leasing and renting of private and council properties.

The South African real estate industry had total revenues of \$26.6m in 2019, representing a compound annual growth rate (CAGR) of 1.2% between 2015 and 2019.

Industry consumption volume increased with a CAGR of 5.1% between 2015 and 2019, to reach a total of 4.5 billion units in 2019.

Rent prices in 2019 were driven lower in line with a decline in property prices and the reduced purchasing power of buyers caused by an economic slowdown and high inflation.
