The US real estate industry recorded revenues of \$1,856.3 billion in 2024, representing a compound annual growth rate (CAGR) of 5.5% between 2019 and 2024.

Industry consumption volume increased with a CAGR of 0.5% between 2019 and 2024, reaching a total of 67.7 million Units in 2024.

High home prices and elevated mortgage interest rates have made

homeownership less attainable for many individuals. This financial barrier has led to increased demand for rental properties, as renting remains a more viable option for those unable to afford
