The residential construction industry within the NAFTA countries had a total market value of \$901,928.5 million in 2020.The US was the fastest growing country, with a CAGR of 5.8% over the 2016-20 period.

Within the residential construction industry, the US is the leading country among the NAFTA bloc, with market revenues of \$746,493.0 million in 2020. This was followed by Canada and Mexico, with a value of \$125,384.3 and \$30,051.2 million, respectively.

The US is expected to lead the residential construction industry in the NAFTA bloc, with a value of \$925,848.1 million in 2025, followed by Canada and Mexico



with expected values of \$166,570.1 and \$44,418.9 million, respectively.
