between 2012 and 2016.

The number of funds increased with a CAGR of 6.8% between 2012 and 2016, to reach a total of 104 funds in 2016.

Sustainability investment funds are leaving behind niche status. One of the success stories has been microfinance which aims to deliver small and medium returns to investors.
