SUMMARY

The Russian chemicals market had total revenues of \$39.6 billion in 2021, representing a compound annual growth rate (CAGR) of 1.4% between 2016 and 2021.

The commodity chemicals segment accounted for the largest proportion of the market in 2021, with total revenues of \$18.9 billion, equivalent to 47.8% of the market's overall value.

The Russian chemicals market declined by 0.6% in 2020, partially caused by the COVID-19 pandemic, which ground much economic activity to a halt. Due to this, the demand for chemicals experienced severe shocks, supply chains were

heavily disrupted, and chemical company stocks took major hits.
