The motor segment accounted for the market's largest proportion in 2022, with total gross written premiums of \$7.7 billion, equivalent to 37.1% of the market's overall value.

In 2022, the Russian non-life insurance market witnessed an annual growth of 8% due to the increase in the number of active non-life insurance policies.
