SUMMARY

Savory & Deli Foods in Canada industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2013-17, and forecast to 2022). The savory and deli foods market consists of the retail sale of cured meats, fermented meats, pâté, pies and savory appetizers, pre-packed sandwiches, prepared salads and savory baked goods. The market is valued according to the retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2017 exchange rates.

The Canadian savory and deli foods market had total revenues of \$1,068.9m in 2017, representing a compound annual growth rate (CAGR) of 4.7% between 2013 and 2017.

Market consumption volume increased with a CAGR of 3.6% between 2013 and 2017, to reach a total of 180.3 million kilograms in 2017.

The rise in hectic and busy lifestyles led Canadians to change their food preference. Therefore, demand for ready to eat and convenient snack options

are increasing.
