## **SUMMARY**

The savory and deli foods market consists of the retail sale of cured meats, fermented meats, pâté, pies and savory appetizers, pre-packed sandwiches, prepared salads and savory baked goods. The market is valued according to the retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2017 exchange rates.

The European savory and deli foods market had total revenues of \$54,301.1m in 2017, representing a compound annual growth rate (CAGR) of 3.1% between 2013 and 2017.

Market consumption volume increased with a CAGR of 1.4% between 2013 and 2017, to reach a total of 5,590.2 million kilograms in 2017.

The European savory and deli foods market is led by the UK with a value share of 25.1% of the region's total savory and deli foods market in 2017.
