Savory Snacks in Scandinavia

SUMMARY

Savory Snacks in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market size (value 2015-19, and forecast to 2024). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The savory snacks market consists of the retail sale of ethnic/traditional snacks, meat snacks, nuts and seeds, popcorn, potato chips, processed snacks and pretzels products. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2019 exchange rates.

The Scandinavian savory snacks market had total revenues of \$1,175.5m in 2019, representing a compound annual growth rate (CAGR) of 3.8% between 2015 and 2019.

Market consumption volume increased with a CAGR of 2.5% between 2015 and 2019, to reach a total of 87.7 million kilograms in 2019.

Positive economic conditions and increasing purchasing power in the country are the key factors supporting the growth of the savory snacks market.
