Scandinavia Air Freight Market @Summary, Competitive Analysis and Forecast, 2017-2026

#### SUMMARY

Air Freight in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-21, and forecast to 2026). ## **KEY HIGHLIGHTS**

The air freight sector is defined as consisting of revenues generated from freight transportation by air.

The Scandinavian air freight sector had total revenues of \$1.4bn in 2021, representing a compound annual growth rate (CAGR) of 1.3% between 2016 and 2021.

Sector production volumes declined with a CAGR of 0% between 2016 and 2021, to reach a total of 1.7 billion freight ton-kilometers (FTK) in 2021.

The sector recorded steep decline in 2020 of 29.7% largely due to the COVID-19 pandemic. The leading players in the region were forced to follow government restrictions in order to curtail the spread of the virus.
