Scandinavia Air Freight Market @Summary, Competitive Analysis and Forecast to 2027

### SUMMARY

Air Freight in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-22, and forecast to 2027). ### KEY HIGHLIGHTS

The air freight sector is defined as consisting of revenues generated from freight transportation by air.

The Scandinavian air freight sector had total revenues of \$1.1 billion in 2022, representing a negative compound annual growth rate (CAGR) of 4.9% between 2017 and 2022.

Sector consumption volumes declined with a negative CAGR of 4.8% between 2017 and 2022, reaching a total of 1.4 billion FTK in 2022.

The Scandinavian air freight sector has declined recently owing to several factors such as increasing interest rates and rising inflation. High-interest rates reduce access to credit for the companies involved, thereby reducing the volume of investment which negatively impacts air freight. For instance, according to the OECD, the long-term interest rates in Norway grew from 1.6% in December

2017 to 3.0% in December 2022.
