### Summary

The apparel segment accounted for the market's largest proportion in 2022, with total revenues of \$24.8 billion, equivalent to 91.7% of the market's overall value.

In Scandinavia, Sweden is the largest market accounting for a share of 34.6% followed by Norway (26.4%), Denmark (21.7%), and Finland (17.3%).
