#### Summary

The total value of the market represents the demand for the service coming from a particular country.

The Scandinavian BPO services market had total revenues of \$5.1 billion in 2022, representing a compound annual growth rate (CAGR) of 6.5% between 2017 and 2022.

The vertical-specific BPO segment accounted for the market's largest proportion



in 2022, with total revenues of \$1.2 billion, equivalent to 24.1% of the market's overall value.

Factors such as the presence of a skilled and experienced workforce, highly proficient in English promote the Scandinavian countries as the key outsourcing destination.
