Summary

Generics in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2017-22, and forecast to 2027). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

Key Highlights

For the purposes of this profile, a generic drug is defined as a copy of an ethical (prescription) drug formerly protected by patents that have now expired. Both unbranded generics and branded generics are included in our market scope. However, off-patent drugs that continue to be offered by the original manufacturer under the original name, and which form part of the 'generic-eligible' market, are not included. The market value is evaluated at ex-factory prices.

The Scandinavian generics market had total revenues of \$3.2 billion in 2022, representing a compound annual growth rate (CAGR) of 2.7% between 2017 and 2022.

Market consumption volume increased with a CAGR of 2.8% between 2017 and 2022, to reach a total of 46.5% in 2022.

The Finnish Medicines Agency (Fimea) received 2,335 reports of issues with medicine shortages in 2022, which are treated with alternates such as generic medications, driving the market growth.
