SUMMARY

Internet Access in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-21, and forecast to 2026). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The internet access sector consists of the total Internet Service Revenue charged for the provision of narrowband and broadband Internet connections through both consumer and corporate channels. All revenues calculated are retail revenues exclusive of taxes. Only fixed communication is included; mobile connections are not considered.

The Scandinavian internet access market had total revenues of \$4,531.2 million in 2021, representing a compound annual growth rate (CAGR) of 3.4% between 2016 and 2021.

Market volume increased with a CAGR of 0.7% between 2016 and 2021, to reach a total of 23.1 million internet users in 2021.

The Swedish market continued to drive growth for the region, accounting for

38.3% of its value in 2021. The Norwegian and Danish markets followed with 28.6% and 24.1%, respectively.
