The Scandinavian jewelry & watches market had total revenues of \$3.8 billion in 2022, representing a compound annual growth rate (CAGR) of 1.7% between 2017 and 2022.

The jewelry & watches segment accounted for the market's largest proportion in 2022, with total revenues of \$2.1 billion, equivalent to 53.7% of the market's overall value.



Scandinavia accounted for 0.62% of the global jewelry & watches market. In Scandinavia, Sweden is the largest market accounting for 36.31% of the Scandinavian market followed by Norway (26.03%), Denmark (23.62%), and Finland (14.04%) in 2022.
