SUMMARY

Residential Construction in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2017-21, and forecast to 2026). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The residential construction market is defined as the value of work put in place annually for residential buildings. Market value is defined in general as the total output value of construction activity in any given time period, including costs related to construction materials, equipment and services for new construction, refurbishment, repair and maintenance and demolition. All market data and forecasts are represented in nominal terms (i.e. without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.

The Scandinavian residential construction market had total revenues of \$118.3bn in 2021, representing a compound annual growth rate (CAGR) of 5.8% between 2016 and 2021.



The new construction segment was the market's most lucrative in 2021, with total revenues of \$68.5bn, equivalent to 57.9% of the market's overall value.

The Scandinavian residential construction saw positive growth in 2021, accelerating levels from the previous year where it grew moderately despite the effects of the pandemic.
