### SUMMARY

Software in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-21, and forecast to 2026). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

### KEY HIGHLIGHTS

The software market is defined as revenues generated from both: sales of, and subscriptions to, various software packages and offerings. The market includes both signed deals that remain under contract, and the annual revenues associated with new contracts signed, within a particular calendar year. This excludes sales opportunities for third-party services providers.

The Scandinavian software market had total revenues of \$14.3 billion in 2021, representing a compound annual growth rate (CAGR) of 6.4% between 2016 and 2021.

The business process applications segment was the market's most valuable in 2021, with total revenues of \$5.2 billion, equivalent to 36.1% of the market's overall value.

The COVID-19 crisis highlighted several examples of processes that can be

digitized and virtualized, which increased demand for software products.
