SUMMARY

Soups in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-21, and forecast to 2026). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The soups market consists of the retail sale of ambient soup, dried soup (mixes), chilled soup, UHT soup and frozen soup products. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2021 exchange rates.

The Scandinavian Soups market had total revenues of \$474.7m in 2021, representing a compound annual growth rate (CAGR) of 4.8% between 2016 and 2021.

Market consumption volume increased with a CAGR of 3.5% between 2016 and 2021, to reach a total of 57.4 million kilograms in 2021.

The performance of the market is forecast to decelerate, with an anticipated CAGR of 3.9% for the five-year period 2021 - 2026, which is expected to drive

the market to a value of \$574.9m by the end of 2026.
