Scottish Re Group Limited (Scottish Re) is a reinsurance provider based in Bermuda. It offers reinsurance of life insurance, annuities and annuity-type products. The company re-insures mortality risk, investment risk, persistency risk and expense risks of the US life insurance and reinsurance companies. It offers reinsurance products such as term life reinsurance, term with multi-year guarantees, ordinary life reinsurance, universal life reinsurance, and variable life reinsurance. Scottish Re also offers reinsurance for deferred annuities and variable annuities. The company through its subsidiaries operates in the Cayman Islands, Bermuda, Ireland, and the US. Scottish Re is headquartered in Hamilton, Bermuda.

The company reported premiums assumed of US\$586.9 million for the fiscal year 2015 (FY2015), representing an annual decline of 5.4% over FY2014. It reported net earned premiums of US\$312.7 million in FY2015, representing a decrease of 11.3% over FY2014.
