The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The seasonings, dressings & sauces industry within the NAFTA countries had a total market value of \$6,416.4 million in 2019. Mexico was the fastest growing country, with a CAGR of 4.8% over the 2015-19 period.

Within the seasonings, dressings & sauces industry, Mexico is the leading country among the NAFTA bloc, with market revenues of \$3,468.3 million in 2019. This was followed by Canada and Canada, with a value of \$2,922.6 and \$2,922.6 million, respectively.

Mexico is expected to lead the seasonings, dressings & sauces industry in the NAFTA bloc, with a value of \$4,334.7 million in 2024, followed by Canada and US with expected values of \$3,343.2 and \$32.0 million, respectively.
