Singapore Air Freight Market @Summary, Competitive Analysis and Forecast, 2017-2026

SUMMARY

Air Freight in Singapore industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2017-21, and forecast to 2026). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The air freight sector is defined as consisting of revenues generated from freight transportation by air.

The Singaporean air freight sector had total revenues of \$4.3 billion in 2021, representing a compound annual growth rate (CAGR) of -0.5% between 2016 and 2021.

Sector production volumes declined with a CAGR of -6% between 2016 and 2021, to reach a total of 4.9 billion freight ton-kilometers (FTK) in 2021.

The sector recorded steep decline in 2020 of 51.6% largely due to the COVID-19 pandemic. The leading players in the region were forced to follow government restrictions in order to curtail the spread of the virus.
