SUMMARY

Apparel & Non-Apparel Manufacturing in Singapore industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-21, and forecast to 2026). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The value of each segment is for consumption, defined as domestic production plus imports minus exports, all valued at manufacturer prices.

The Singaporean market had total revenues of \$4.8 billion in 2021, representing a compound annual growth rate (CAGR) of 2.1% between 2016 and 2021.

The apparel segment was the market's most lucrative in 2021, with total revenues of \$4.5 billion, equivalent to 94.6% of the market's overall value.

The market recorded consistent growth in the years preceding 2019, which will have been aided by wider macroeconomic growth in the economy. The market's steep slowdown to declining 3.0% growth in 2020 was largely induced by the COVID-19 pandemic.
